### **Organizational Setting**

The Forest Policy and Resources Division provides services to member countries on matters relating to the forest assessment, development, management, conservation, restoration and protection of forests, trees, water, mountains, biodiversity, wildlife and related natural resources as well as for providing a neutral forum for the discussion of such topics. Other topics of interest for the Division are agroforestry, urban forestry, and forests and climate change, including Reducing Emissions from Deforestation and Forest Degradation (REDD+).

The post is located in Naypyitaw, Myanmar, as part of the FAO team of the United Nations Collaborative Programme on Reducing Emissions from Deforestation and Forest Degradation in Developing Countries (UN-REDD). The post is part of the Programme Management Unit (PMU) of the Myanmar UN-REDD National Programme and will serve as the Technical Advisor of the Myanmar National Forest Inventory (NFI) and National Forest Monitoring and Information System (NFMIS) project supported by the Government of Finland.

## **Reporting Lines**

The Forestry Officer reports to the FAO REDD+ Team Leader. Under the overall managerial and administrative leadership of the FAO Representative (FAOR) in Myanmar and in close collaboration with the FAO REDD+ regional coordination team for Asia and the Pacific, FAO Forestry experts in Headquarters and the Regional Office for Asia and the Pacific (RAP), the National Programme Director (NPD) of the Myanmar UN-REDD National Programme and the NPD of the Myanmar NFI/NFMIS project, the incumbent will have the following duties:

### **Technical Focus**

The Forest Officer will provide technical expertise to support the planning, financing, development and implementation of the Myanmar NFI/NFMIS project and the FAO-supported components of the Myanmar UN-REDD National Programme.

## **Key Results**

Comprehensive technical and policy expertise to support the planning, financing, development and implementation of the Myanmar NFI/NFMIS project and the FAO-supported components of the Myanmar UN-REDD National Programme.

## **Key Functions**

- Plans and leads components of multi-disciplinary teams, leads and/or participates in internal committees, project teams, and working groups and/or provides specialized expertise on technical networks and/or international technical policy andor international technical policy and standard setting bodies;
- Develops technical, analytical, monitoring and reporting frameworks, and related methodologies, tools, systems
  and databases etc. to support the planning, implementation/delivery and monitoring of programmes of work,
  projects, products and/or services;
- Designs and conducts research, data collection, validation, analysis and/or reporting activities to support the
  development of technical standards, international instruments, innovative approaches and strategies, new tools,
  technologies, technical reports/publications, and/or policy proposals as well as the provision of
  technical/policy/specialist/advice and expertise;
- Responds to country requests for technical and policy assistance, provides technical advice, assistance and solutions to Decentralized Offices and provides technical backstopping to field projects;
- Collaborates in, provides technical backstopping to and ensures the quality/effectiveness of capacity development and knowledge sharing activities within member countries such as policy support, organizational development and individual learning events inculding preparation of related information, learning materials, on-line tools;
- Promotes international cooperation/advocates best practices, increased policy dialogue and provides technical

- expertise at international/intergovernmental meetings;
- Participates in resource mobilization activities in accordance with the FAO Corporate strategy.

## **Specific Functions**

- Provides technical advice on the implementation of Myanmar's REDD+ Readiness Roadmap, with a focus on the
  components related to National Forest Monitoring System (NFMS) and Forest Reference Levels (FRLs) for
  REDD+; provide technical support to the development of a functional satellite-based land monitoring system
  (SLMS) based on available national technical, financial and human resources and advisory services for the
  development of feasible approaches for land use, land use change and forestry related GHG emission calculation
  (activity data and emission factors)
- Supports the implementation of Myanmar's NFMS Action Plan, in close collaboration with the Forest Department, the REDD+ focal point in Myanmar and other relevant stakeholders; and support the implementation of Myanmar's FRL Action plan for eventual submission of FRL to the UNFCCC assessment process
- Supports REDD+ focal point in resource mobilisation efforts for financing the NFMS and the FRL action plans and support the development of data collection, analysis and database management approaches for the NFI;
- Develops and initiate a work plan for the NFI/NFMIS project, in collaboration with NPD; work closely with the NPD, other national counterparts to implement NFI/NFMIS project activities according to the work plan and also with partners in Myanmar and elsewhere to ensure coordination and complementarities in the implementation of the UN-REDD National Programme, in synergy with regional and international initiatives;
- Supports national and subnational consultations with relevant stakeholders on NFMS and FRL development and implementation including the design and delivery of awareness raising and communications materials;
- Facilitates advisory support to government officials in the organization and delivery of training of national staff involved in NFMS and FRLs and coordination of NFMS and FRL development with other components of the Myanmar UN-REDD National Programme in Myanmar, particularly development of a national REDD+ strategy;
- Coordinates activities under the Myanmar UN-REDD National Programme and NFI/NFMIS project with the
  implementation of other FAO forestry projects and activities, including the TCP project on 'Strengthening
  Myanmar's National Forest Monitoring System', the FAO GEF project 'Sustainable Forest and Cropland
  Management in Priority Agro-Ecosystems of Myanmar' and the EU-FAO-FLEGT programme;
- Assists in the recruitment of national and international consultants and staff for the NFI/NFMIS project; perform other technical and operational duties, as necessary.
